Mount Isa City Council News

Recently, this newspaper ran a story about the delay in the announcement of the \$20 million in State Government funding from the Mount Isa Transition Fund, to assist the community before next year's closure of the copper operations at Mount Isa Mines.

While that funding was celebrated upon its announcement, it has become clear, through Council's Economic Development Plan, that it is not going to be nearly enough. And with the holdup of the announcement, this has meant a holdup with projects – projects that may have already been started are on hold, so as to remain eligible for funding

Despite not being in a marginal seat, what we need from the State Government is support like that received by Rio Tinto to keep 1000 jobs in Gladstone - tax dollars used to strike a deal that is commercial-in-confidence but has been confirmed to be well in

excess of \$300 million. It makes our community feel very undervalued when only \$20 million is allocated to help with the loss of 1200 jobs. Let me reiterate - the support to Rio Tinto for a job in Gladstone is worth well north of \$300,000 per job, while Mount Isa jobs are worth \$16.660.

The National Bush Summit in Townsville on August 23 highlighted the importance of the bush to both levels of government. The North West Minerals Province is touted as being the key to decarbonisation and will continue to be seen as a cash cow by both levels of government.

Currently the Federal Government

makes \$800 million per year from the Mount Isa area, and the Mount Isa Diversification and Transformation Investment Strategy outlines how returning just two-and-a-half years' worth of that revenue could secure that continued flow to the Federal Government for the next 100 years.

Council has been proactive in investing in this research and strategy to make this as easy as possible for government to understand and fund.

Investment is required by both government and industry, and even if 25% of the primary projects identified in the strategy come to fruition, Mount Isa has a bright and dynamic future.

News In Brief

• On August 29, Mayor Peta MacRae, Deputy Mayor Kim Coghlan, and Councillors John Tully and John Doyle met and sat down with **Queensland Shadow** Minister for Water, Energy, Regional **Development and Manufacturing Deb** Frecklington MP, as well as Yvonne Tunney, who is the Liberal National Party's (LNP) candidate for the Traeger electorate for October's state election. The issues discussed included the proposed North West Water entity for Mount Isa and Cloncurry councils; youth crime; the proposed correctional precinct for Mount Isa; and the Waste Levy. Ms **Frecklington informed** the councillors about the LNP's plans to overhaul the Juvenile Justice Act, should they be elected in October, including "adult time for adult crime", and mandatory 12-month monitoring of children convicted of crimes. Cr MacRae told Ms Frecklington about the costs and challenges Council faces from having to be included in the State Government's Waste Levy

Council has endorsed the construction of wider shared pathways to replace existing footpaths on Fourth Avenue, as well as along Urguhart Street and Tharrapatha Way.

The 3.4km-long shared pathway on Urquhart Street and Tharrapatha Way will run from Milne Bay Road to Alma Street, while another 1km section will run from the Barkly Highway to Camooweal Street, via Sulphide and Alma streets.

Culverts on Tharrapatha Way will be widened in preparation for the shared path to be constructed in 2025-26.

At its August Ordinary Meeting on August 28, Council also agreed to apply for funding for the creation of an options analysis and detailed design for:

 A 325m-long shared pathway from the Fourth Avenue bridge to the Isa Street Bridge;

• A 1.23km-long off-road shared path from the Isa Street Bridge to Alma Street - or a shared footpath and/or on-road cycle lane along West Street, from Isa Street to Alma Street;

Tip Tokens Scheme Continues

Council wishes to advise that, in lieu of physical tip tokens, residents can continue to present their current rates notice, driver's licence, or a utility bill with a residential Mount Isa address to claim free residential refuse disposal from 1 September 2024 to 30 June 2025.

This method of redeeming tip tokens was introduced last year, and Council endorsed the program again at the Ordinary Meeting held on Wednesday, August 28.

The tip tokens scheme can be accessed on six (6) occasions per residential property and will be valid until June 30, 2025.

The works and options analyses will be partly funded by the State Government's Cycle Network Local Government Grant Program.

Council has approved \$926,000 in the 2024-25 capital works budget - and \$1.17 million in the 2025-26 capital works budget - for the pathways.

Anticipated funding from the State Government's Cycle Network Local Government Grant Program for the 2024-25 financial year is \$981,300, and \$3.27 million for the 2025-26 financial year

At the Ordinary Meeting, Deputy Mayor Kim Coghlan said the existing footpaths will need to be removed as part of the project, in order to meet the requirements of the funding Council has received/will receive.

"It's a complete project, so anything there has to get removed, and put in for new. I think this is going to be very welcomed in our community, especially with Tharrapatha Way, which is well used every day, especially on Saturdays with Park Run," Cr Coghlan said.
