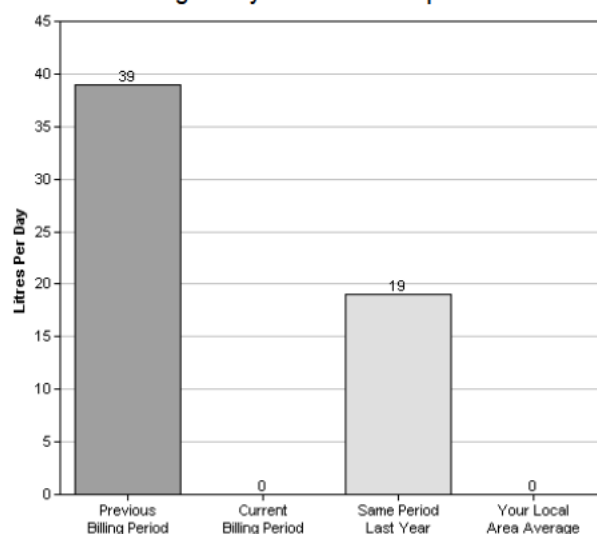

## Understanding Your Water Consumption Billing

Water Consumption is billed progressively throughout the **Financial Year (01 July to 30 June)**, which means that the Tier Tariff levels used to calculate your bill does not reset during the Financial Year.

Properties are issued Water Consumption Notices for Billing Periods within the Financial Year.

Residential properties have two (2) billing periods from **01 July to 31 December** and **1 January to 30 June**.

Non-Residential (Commercial) properties have four (4) billing periods from **01 July to 30 September**, **01 October to 31 December**, **01 January to 31 March** and **01 April to 30 June**.

The below readings show the opening Meter Reading from 1 July for a non-residential property.

All the **466kL** is calculated in the Tier 1 Tariff for the current billing period. In the next billing period below from 1 October to 31 December there is a total of **1045kL** consumed.
